The continuing construction of the Overlook and Claremont housing developments along Lawyers' Hill Road is causing the clear-out of significant areas of woodlands in the area.

As a result of this disruption, many animals are looking for new "homes" in as-yetundisturbed locations... including the woods around our community. Gables homeowners are already seeing more deer, foxes, raccoons, possums, groundhogs, rabbits, turtles, and snakes in the area.

Please be aware of this influx of new "neighbors", and be sure to secure your trash containers, watch out for damage to your landscaping plants, and be careful when driving along our community roadways.

FOOTNOTE: Vehicular traffic along Summer Home Terrace is also increasing. - adding yet another reason for extra caution when you are driving or walking through The Gables.

### NEW GROCERY STORE AT ELKRIDGE CORNERS

Remember the song words "You don't know what you've got till it's gone"?

Well, to those of us who have been sorely missing the convenience of having a fully-stocked grocery store right around the corner, there's great news!

**Green Valley Marketplace** will open its doors for business at **7AM on Wednesday, November 16**<sup>th</sup> at the former site of the SuperFresh store at the corner of Montgomery Rd and Washington Blvd.

An independent grocery store owned by a Baltimore company (B. Green Wholesale) which has been in business since 1915, this store is being designed to cater to the Elkridge community. With an on-site bakery for bread, muffins, and cakes, freshly prepared foods (including steamed crabs!), organic items, and competitive pricing, it should be a welcome addition to our community.

The old grocery store space at Elkridge Corners shopping center is being fully renovated with a new floor, all new shelving, and a new facade on the front of the building. The store has created more than 100 jobs for Elkridge.

The owners of the store have expressed to Councilwoman Courtney Watson that they want to be part of our community, and they welcome feedback from Elkridge residents.
